Fund Manager comments

Echiquier QME ended the month higher, buoyed by continuing favourable trends in equity indices, currencies and commodities.

The equities portfolio (+2.3%) continued to benefit from strong trends. Bullish exposure is stable. The average beta is close to 30% and Europe remains overweight.

Positions in government bonds (-0.1%) ended close to balance. The model maintains a marginal position in this asset class, due to diverging signals.

In currencies (+0.5%), the fund is slightly bullish on the US dollar against the currencies of developed countries. The model also remains a buy on South American currencies (Mexican peso and Brazilian real). Finally, in commodities (+0.5%), the fund benefited from favourable momentum in oil products and precious

metals. The composite signal remains bullish on energy products, and more marginally on metals. Fund Managers: Alexis Grutter, Ludovic Berthe
