#### Fund Manager comments

Echiquier Agenor Euro SRI Mid Cap G turned in a positive monthly performance of 2.85% and of 3.07% year-todate.

Equity markets are rising, buoyed by solid macroeconomic data in the United States and the gradual rebound in leading indicators in Europe. Value themes, particularly financials, outperformed significantly as expectations of rate cuts eased in the face of a more resilient macroeconomic picture than expected. The fund limited its underperformance, supported in particular by the rebound in NEOEN (+50bp), which indirectly benefited from the KKR fund's takeover bid for ENCAVIS, bringing out the high valuation multiples for this renewable energy asset. IMCD and SPIE (both up 40bp) were buoyed by a very good operating performance and persistently attractive valuations. BE SEMI was the only significant negative contributor over the month (-46bp). The group could be affected by a change in specifications for memory chips, which would delay the adoption of Hybrid Bonding technology. In March, we exited the lightly-weighted REMY COINTREAU, whose operational performance did not match our expectations. We continued to add to our position in PUUILO and strengthened some positions following the publication of results (NEOEN). Fund Managers: Stéphanie Bobtcheff, José Berros




# **Geographic breakdown** (% of the net assets without cash)








