## What is this product?

**TYPE** | Subfund of a SICAV (open-end investment company) governed by French law. Each shareholder has co-ownership rights on the SICAV's net assets in proportion to the number of shares held.

**A.M.F. classification** | International equities

**TERM** | The fund was created on 19/09/2019 and its expected term is 99 years. This term may be extended or the fund may be dissolved early at the initiative of the SICAV's Board of Directors. The terms and conditions for extension or dissolution are described in more detail in the articles of association of the SICAV. The Fund has no maturity date.

**OBJECTIVES** | A UCITS classified as "International equities", ECHIQUIER HEALTH IMPACT FOR ALL is a subfund seeking long-term performance net of management fees through exposure to international equity markets via companies whose business activities provide solutions to the challenges of access to healthcare and which stand out for the quality of their governance and their environmental and social policies. This objective is associated with an extra-financial approach that takes into account Environmental, Social, and Governance (ESG) criteria and an impact score.

The index, composed of 2/3 MSCI Europe Health Care and 1/3 MSCI World Health Care, is used for illustrative purposes only. This index is representative of the management of ECHIQUIER HEALTH IMPACT FOR ALL. The MSCI Europe Health Care index represents the performance of large and mid-cap stocks in 15 European countries in the health care sector (calculated in euros, dividends reinvested).

The MSCI World Health Care index represents the performance of large and mid-cap stocks in 23 developed countries in the health care sector (calculated in euros, dividends reinvested). Investors are advised that the portfolio's composition may differ from that of the benchmark index.

Investors are reminded that their investment in the subfund does not have any direct impact on accessibility to health care, but the subfund seeks to select and invest in companies that meet specific criteria defined in the management strategy.

ECHIQUIER HEALTH IMPACT FOR ALL implements an active and discretionary management strategy focused on international equity markets. ECHIQUIER HEALTH IMPACT FOR ALL has a minimum exposure of 60% of its net assets on equity markets of the health care sector. ECHIQUIER HEALTH IMPACT FOR ALL applies three extra-financial filters in its stock-picking: after controversial sectors and practices are excluded, these companies must meet a minimum ESG rating requirement as well as a minimum impact score requirement. Finally, a financial selection is applied, leading to the construction and management of the portfolio.

ECHIQUIER HEALTH IMPACT FOR ALL implements an active and discretionary management approach based on rigorous stock picking, obtained through a process involving direct meetings with the companies in which the subfund invests. The manager can invest in equities from all geographical

regions, including emerging countries within the limit of 20% of net assets, and all capitalisations, while favouring mid and large caps (investment of up to 60% of net assets).

Lastly, for cash management purposes, the subfund may invest up to 10% of net assets in short-term debt securities in the investment grade category (i.e. rated at least BBB- by Standard & Poor's or equivalent or considered as such by the management team). At the time of acquisition and for monitoring purposes over the life of the securities, credit risk is assessed on the basis of in-house research and analysis by La Financière de l'Échiquier and using the ratings produced by agencies. The fund can also invest in shares or units of French and/or European UCITS or in shares or units of retail investment funds within the limit of 10% of its net assets.

Derivative instruments, both traded on a regulated market or over the counter, can be used on an exceptional and discretionary basis to:

- Hedge the portfolio against currency risk and against equity risk when the manager anticipates a significant deterioration in the performance of the market (within the limit of the minimum exposure of 60% of net assets);
- Occasionally expose the portfolio to equity risk during significant subscription transactions. The fund does not, in any event, intend to implement a strategy of over-exposing the portfolio to equity risk.

**Cut-off time for centralising subscription/redemption orders** | The investor may obtain a redemption on request every business day. Redemption requests are centralised each market trading day before 12 p.m. (Paris time) with our centralising agent BNP Paribas SA and executed on the net asset value calculated on the closing price on the day they are centralised.

**Valuation frequency** | The net asset value is calculated daily except on days when the Paris stock exchange is closed and on French public holidays.

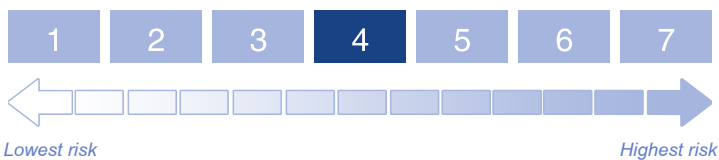

## What are the risks and what could I get in return?

### Risk indicator



The risk indicator is based on the assumption that you hold the shares for 5 years.



The real risk can be very different if you opt for an exit before this period, and you could get less in return.

The synthetic risk indicator makes it possible to assess the level of risk of this product compared to others. It indicates the likelihood that this product will incur losses in the event of market movements or if we are unable to pay you.

We have classified the product in risk class 4 out of 7, which is a medium risk class. In other words, the potential losses related to the product's future results are at a medium level and, if the situation deteriorates on the financial markets, it is possible that our ability to pay you will be affected.

## What happens if La Financière de l'Échiquier is unable to pay out?

The product is a co-ownership of financial instruments and deposits separate from the management company. In the event of failure of the latter, the assets of the product held in custody by the depositary will not be affected. In the case of failure of the depositary, the risk of financial loss for the product is reduced due to the legal segregation of the assets of the depositary and those of the product.

## What are the costs?

### Costs over time:

The tables show the amounts deducted from your investment in order to cover the different types of costs. These amounts depend on the amount you invest, the time you hold the product, and the product's return. We assumed:

- that in the first year you will recover the amount you invested (annual return of 0%). That for other holding periods, the product changes as indicated in the moderate scenario.
- EUR 10,000 is invested.

#### How long should I hold it and can I take money out early?

Recommended holding period: at least 5 years due to the nature of the assets underlying this investment.
