What is this product?

TYPE | Fonds Commun de Placement (mutual fund) under French law. Each unitholder has a co-ownership right to the fund's assets in proportion to the number of units held.

A.M.F. classification International equities

TERM | The fund was created on 09/05/2007 and its expected term is 99 years. This term may be extended or the fund may be dissolved early at the initiative of the management company. The terms and conditions for extension or dissolution are described in the fund rules. The Fund has no maturity date.

OBJECTIVES

Echiquier Luxury is a UCITS classified under "International Equities" that seeks to outperform (net of management fees) its benchmark index, the MSCI World, over the recommended investment period of 5 years.

To achieve its investment objective, the UCITS implements active and discretionary management. The management team invests primarily in equities (at least 60% of net assets), debt securities and money market instruments.

Investment in equities in the luxury sector will be made based on macroeconomic analysis in order to determine the leaders that create value and having good earnings visibility. The Fund may invest in large and mid caps as well as in emerging markets.

The UCITS has a benchmark index: the MSCI WORLD INDEX NR (in EUR), calculated in euros and dividends reinvested. Information about the index is available at <http://www.msci.com/>. The benchmark is only used as an ex-post performance indicator. The management of this UCITS is neither index-linked nor index-referenced. No correlation is sought with the benchmark index. The portfolio composition therefore does not track that of the index

, and the Fund's performance may deviate from this benchmark in the long term.

Equities: minimum exposure of 60% and up to 100% of net assets. International equities, in particular emerging market equities.

Debt securities: up to 40% of net assets in securities denominated in euros. Echiquier Luxury can also invest in debt securities issued by the United States within the limit of the regulatory ratios. The Fund may invest on an ancillary basis in fixed-income products not denominated in euros or US dollars.

The investment will be made in equities in the luxury sector, and on an ancillary basis in non-luxury stocks.

The Fund's management is fully discretionary.

Cash management is carried out, among other things, through holdings of euro and non-euro money market and bond instruments.

Investment in derivatives provides hedging or exposure to equities, equity indices, and currencies. The sum of commitments relating to derivatives is limited to 100% of net assets. Derivatives are used without seeking overexposure.

Echiquier Luxury is therefore subject to currency risk, which can range from 0% to 100% of net assets.

Furthermore, the portfolio management team systematically includes an extra-financial approach in building the portfolio, although extra-financial criteria are not a determining factor in investment decisions.

Cut-off time for centralising subscription/redemption orders | The investor may obtain a redemption on request every business day. Valuation frequency | The net asset value is calculated daily except on days when the Paris stock exchange is closed and on French public holidays.

What are the risks and what could I get in return?

Risk indicator



The risk indicator is based on the assumption that you hold units for 5 years.

 The real risk can be very different if you opt for an exit before this period, and you could get less in return.

The synthetic risk indicator makes it possible to assess the level of risk of this product compared to others. It indicates the likelihood that this product will incur losses in the event of market movements or if we are unable to pay you.

We have classified the product in risk class 4 out of 7, which is a medium risk class. In other words, the potential losses related to the product's future results are at a medium level and, if the situation deteriorates on the financial markets, it is possible that our ability to pay you will be affected.

Risks materially relevant and not taken into account in the indicator: Liquidity risk, Impact of techniques such as the use of derivatives.

The stress scenario shows what you could get in extreme market situations.

Unfavourable scenario: this type of scenario occurred for an investment in the product between 31/10/2021 and 31/10/2022 (1-year scenario) and between 31/03/2015 and 31/03/2020 (5-year scenario)

Moderate scenario: this type of scenario occurred for an investment in the product between 31/03/2016 and 31/03/2017 (1-year scenario) and between 30/06/2017 and 30/06/2022 (5-year scenario)

Favourable scenario: this type of scenario occurred for an investment in the product between 31/07/2020 and 31/07/2021 (1-year scenario) and between 30/11/2016 and 30/11/2021 (5-year scenario)

What happens if La Financière de l'Échiquier is unable to pay out?

The product is a co-ownership of financial instruments and deposits separate from the management company. What are the costs?

- that in the first year you will recover the amount you invested (annual return of 0%). That for other holding periods, the product changes as indicated in the moderate scenario.
