## What is this product?

**Type** | Subfund of a SICAV (open-end investment company) governed by French law. Each shareholder has co-ownership rights on the SICAV's net assets in proportion to the number of shares held.

**A.M.F. classification** | Equities of eurozone countries

**Term** | The Fund was created on 27/12/2018 and its expected term is 99 years. This term may be extended or the Fund can be dissolved early on the initiative of its Board of Directors. The terms and conditions for extension or dissolution are described in more detail in the articles of association of the SICAV. The Fund has no maturity date.

**Objectives** | Echiquier Agenor Euro SRI Mid Cap aims to outperform the Euro MSCI EMU Mid Cap index (dividends reinvested) through discretionary and opportunistic management on equity markets of small and mid-caps of the eurozone, using a dual "best-in-universe" and "best-effort" ESG approach.

The management objective of the UCITS is combined with an extra-financial approach incorporating environmental, social, and governance (ESG) criteria, such as the issuer's environmental policy, employee protection or the competence of the management team. The extra-financial objective is to help companies move forward on ESG issues by engaging in dialogue with them on a regular basis and by sharing with them specific areas of improvement monitored over time.

The MSCI EMU Mid Cap index (Bloomberg ticker M7EMMC) is a representative indicator of the management of Echiquier Agenor Euro SRI Mid Cap. This index shows the evolution of mid-cap equities in the Eurozone. It is calculated in euros, with dividends reinvested. Investors are advised that the portfolio's composition may differ from that of the benchmark index.

The UCITS implements an active and discretionary management approach based on a rigorous selection of securities obtained through the implementation of an in-depth evaluation process for the companies in the portfolio. Echiquier Agenor Euro SRI Mid Cap is invested in stocks from all sectors and of all capitalisations. It should be noted, however, that the subfund is exposed mainly to small and mid-caps (those with a market capitalisation of less than 10 bn euros). This UCITS is mainly invested in eurozone equities, but may invest up to 10% of its net assets in equities of non-eurozone countries. In order for the UCITS to be eligible for PEAs, a minimum of 75% is invested at all times in financial instruments eligible for PEAs.

In constructing the portfolio and assessing extra-financial criteria, the management team selects stocks according to an internal ESG rating methodology, after applying a sector exclusion filter.

This approach may have certain methodological limits detailed in the prospectus. In addition, for more detailed information on the extra-financial rating methodology used for the UCITS and its limits, investors should refer to the Transparency Code of La Financière de l'Echiquier available on [www.lfde.com](http://www.lfde.com).

The UCITS reserves the right to invest a maximum of 25% in fixed-income products. At the time of acquisition and for monitoring purposes over the life of the securities, credit risk is assessed on the basis of in-house research and analysis by La Financière de l'Echiquier and using the ratings produced by agencies. Eligible securities are deemed investment grade, i.e., having a minimum Standard & Poor's rating of BBB- or equivalent or considered as such by the management team.

Up to 10% of the UCITS' assets may be invested in units or shares of French and/or European UCITS and in retail investment funds. This will be a UCI in any AMF category provided it is not in conflict with investment strategy. It may be UCIs managed by the management company or by an associate company.

The UCITS prohibits any investment in derivative products or securities with embedded derivatives.

**Cut-off time for centralising subscription/redemption orders** | The investor may obtain a redemption on request every business day. Redemption requests are centralised each market trading day before 12 p.m. (Paris time) with our centralising agent BNP Paribas SA and executed on the net asset value calculated on the closing price on the day they are centralised.

**Valuation frequency** | The net asset value is calculated daily except on days when the Paris stock exchange is closed and on French public holidays.

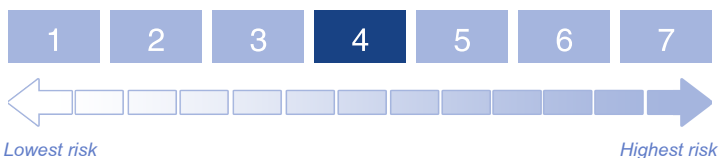

## What are the risks and what could I get in return?

### Risk indicator



The risk indicator is based on the assumption that you hold the shares for 5 years.



The real risk can be very different if you opt for an exit before this period, and you could get less in return.

The synthetic risk indicator makes it possible to assess the level of risk of this product compared to others. It indicates the likelihood that this product will incur losses in the event of market movements or if we are unable to pay you.

We have classified the product in risk class 4 out of 7, which is a medium risk class. In other words, the potential losses related to the product's future results are at a medium level and, if the situation deteriorates on the financial markets, it is possible that our ability to pay you will be affected.

The stress scenario shows what you could get in extreme market situations.

Unfavourable scenario: this type of scenario occurred for an investment in the product between 30/09/2021 and 30/09/2022 (1-year scenario) and between 31/03/2015 and 31/03/2020 (5-year scenario)

## What happens if La Financière de l'Échiquier is unable to pay out?

The product is a co-ownership of financial instruments and deposits separate from the management company. In the event of failure of the latter, the assets of the product held in custody by the depositary will not be affected. In the case of failure of the depositary, the risk of financial loss for the product is reduced due to the legal segregation of the assets of the depositary and those of the product.

## What are the costs?

### Costs over time:

The tables show the amounts deducted from your investment in order to cover the different types of costs. - that in the first year you will recover the amount you invested (annual return of 0%). That for other holding periods, the product changes as indicated in the moderate scenario.
