What is this product?

TYPE | Subfund of a SICAV (open-end investment company) governed by Luxembourg law. Each shareholder has co-ownership rights on the SICAV's net assets in proportion to the number of shares held.

TERM | The fund was created on 08/11/2013 for an unlimited term.

OBJECTIVES | Echiquier World Equity Growth Fund is a dynamic subfund seeking long-term performance via exposure to growth stocks in international markets. The subfund invests in stocks with confirmed global leadership positions in their industry.

The MSCI All Country World Index can be used as an ex-post benchmark for its performance. This index is used solely for information purposes and is calculated in euros, dividends reinvested, by MSCI. It includes 50 countries (developed and emerging countries).

The management of the subfund is based on a rigorous securities selection process (stock picking). The investment strategy is intended to select stocks which provide the best current or potential growth, which are leaders in markets of significant size in all regions of the world.

The subfund has a minimum 60% exposure to the equities of the eurozone and/or international and emerging markets. The subfund's assets consist primarily of large caps. However, the subfund reserves the right to invest up to 10% in small and mid-caps. The UCITS reserves the right to invest up to a maximum of 40% in fixed-income products. At the time of acquisition and for monitoring purposes over the life of the securities, credit risk is assessed on the basis of in-house research and analysis by La Financière de l'Échiquier and using the ratings produced by agencies. The eligible securities in question are deemed to be investment grade, i.e., having a minimum Standard & Poor's rating of BBB- or equivalent or considered as such by the management team.

Financial derivative instruments, both traded on regulated markets or over the counter, can be used on an exceptional basis to:

- Hedge the portfolio against currency risk and against equity risk when the manager anticipates a significant deterioration in market performance;

- Occasionally expose the portfolio to equity risk during significant subscription transactions. The subfund does not, in any event, intend to implement a strategy of over-exposing the portfolio to equity risk.

Furthermore, the portfolio management team systematically includes an extra-financial approach in building the portfolio, although extra-financial criteria are not a determining factor in investment decisions.

What are the risks and what could I get in return?

Risk indicator



The risk indicator is based on the assumption that you hold the shares for 5 years.

 The real risk can be very different if you opt for an exit before this period, and you could get less in return.

The synthetic risk indicator makes it possible to assess the level of risk of this product compared to others. It indicates the likelihood that this product will incur losses in the event of market movements or if we are unable to pay you.

We have classified the product in risk class 4 out of 7, which is a medium risk class. In other words, the potential losses related to the product's future results are at a medium level and, if the situation deteriorates on the financial markets, it is possible that our ability to pay you will be affected.

The stress scenario shows what you could get in extreme market situations.

Unfavourable scenario: this type of scenario occurred for an investment in the product between 30/12/2021 and 30/12/2022 (1-year scenario) and between 30/03/2015 and 30/03/2020 (5-year scenario)

Moderate scenario: this type of scenario occurred for an investment in the product between 30/08/2016 and 30/08/2017 (1-year scenario) and between 30/05/2014 and 30/05/2019 (5-year scenario)

What happens if La Financière de l'Échiquier is unable to pay out?

The product is a co-ownership of financial instruments and deposits separate from the management company.
