What is this product?

TYPE | Fonds Commun de Placement (mutual fund) under French law. Each unitholder has a co-ownership right to the fund's assets in proportion to the number of units held.

TERM | The Fund was created on 29/09/2016 and its expected term is 99 years. This term may be extended or the Fund can be dissolved early on the initiative of its Board of Directors. The terms and conditions for extension or dissolution are described in more detail in the articles of association of the SICAV. The Fund has no maturity date.

OBJECTIVES | The fund's investment objective is to outperform, net of management fees, the Markit iBoxx Euro Liquid High Yield Index, representative of the performance of private bonds in euros (calculated with coupons reinvested and in euros).

This objective is combined with an extra-financial approach, integrating the consideration of environmental, social, and governance (ESG) criteria, such as the issuer's environmental policy, employee protection and expertise of the Management team, in accordance with a dual ESG Best in Universe and Best Effort approach. The extra-financial objective is to help companies move forward on ESG issues by engaging in dialogue with them on a regular basis and by sharing with them specific areas of improvement monitored over time.

In constructing the portfolio and assessing extra-financial criteria, the management team selects securities according to an internal ESG rating methodology: after exclusion of controversial sectors and practices, the companies must meet a minimum ESG rating.

The investment strategy of the Echiquier High Yield Europe fund is based on active and discretionary management with rigorous bond-picking that is implemented through a variety of strategies, combining both a top down and bottom up approach. The investment strategy, based on management of currency and credit risks, aims to select securities with residual maturity close to the Markit iBoxx Euro Liquid High Yield index but is not exclusively restricted to these. It is subject to changes in the euro fixed-income markets, as well as changes in risk premiums. In order to achieve its investment objective, the subfund is exposed to bonds and debt securities mainly from private issuers, but reserves the right to invest in government bonds on an ancillary basis.

The range of interest rate sensitivity within which the Fund is managed is between 0 and 8.

The fund invests in fixed-income products mostly denominated in euros. Exposure to instruments issued in other currencies cannot exceed 10%, irrespective of the nationality of the issuer.

More specifically, it invests in bonds of the Europe region (European Union + European Free Trade Association + United Kingdom) and, within the limit of 10% maximum of net assets, in bonds outside this region, including securities issued by emerging country issuers.

The allocation between the ratings of the various issuers will be as follows:

- 0% to 100% of net assets in high yield securities: securities rated below or equal to "BB+" according to Standard & Poor's or any equivalent rating by Moody's or Fitch) or deemed equivalent by the management company;

- the selection of securities will be limited to securities with a rating of "B-" or higher at the time of investment according to the rating agency Standard & Poor's or any equivalent rating by Moody's or Fitch or a rating deemed equivalent by the management company;

- 0% to 100% of net assets in non-OECD countries.

The issuers of such instruments will be subject to monitoring by the in-house research team of La Financière de l'Echiquier, which does not automatically or exclusively use ratings from rating agencies.

The manager may also invest up to a maximum of 40% of its net assets in subordinated bonds of the banking, insurance and corporate sectors, including a maximum of 10% in contingent convertible bonds ("CoCos").

The fund reserves the right to deal in financial derivative instruments traded on regulated European and international markets. In this context, the UCITS will take positions to hedge the portfolio against interest rate risk and any currency risk. It may also use exposure to derivatives for the purpose of managing interest rate risk.

The fund's extra-financial approach may involve certain methodological limits detailed in the prospectus. Valuation frequency | The net asset value is calculated daily except on days when the Paris stock exchange is closed and on French public holidays.

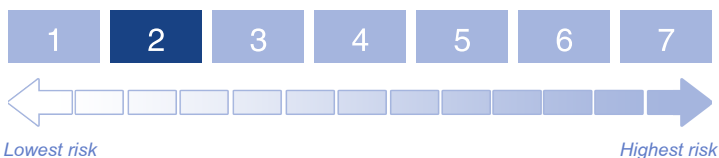

What are the risks and what could I get in return?

The risk indicator is based on the assumption that you hold units for 3 years.



The real risk can be very different if you opt for an exit before this period, and you could get less in return.

The synthetic risk indicator makes it possible to assess the level of risk of this product compared to others. It indicates the likelihood that this product will incur losses in the event of market movements or if we are unable to pay you.

We have classified the product in risk class 2 out of 7, which is a low risk class. In other words, the potential losses linked to the product's future results are low and, should the situation deteriorate on the financial markets, it is highly unlikely that our ability to pay you will be affected.

What happens if La Financière de l'Échiquier is unable to pay out?

The product is a co-ownership of financial instruments and deposits separate from the management company. What are the costs?

Costs over time:

The tables show the amounts deducted from your investment in order to cover the different types of costs. - that in the first year you will recover the amount you invested (annual return of 0%). That for other holding periods, the product changes as indicated in the moderate scenario.
