What is this product?

TYPE | Subfund of a SICAV (open-end investment company) governed by Luxembourg law. Each shareholder has co-ownership rights on the SICAV's net assets in proportion to the number of shares held.

TERM | The fund was created on 15/12/2022 for an unlimited term.

OBJECTIVES | The Echiquier Go Local subfund is a dynamic subfund seeking long-term performance through exposure to international equity markets, more specifically in companies working to promote the local economy.

The MSCI All Country World Index can be used as an ex-post benchmark for its performance. This index is used solely for information purposes and is calculated in euros, dividends reinvested, by MSCI. It includes 50 countries, including developed and emerging countries. Investors are advised that the portfolio's composition may differ from that of the benchmark index.

The UCITS implements active and discretionary management based on a rigorous stock-picking process. The subfund invests in companies that aim to empower their region by buying or producing locally, by repatriating a business activity to a region close to its consumer market, or by facilitating these business activities by contributing innovative solutions or adapted infrastructures. The activity sectors favoured by the management team will be technology, industry, healthcare and food.

The subfund is exposed at least 60% to the international equity market with an exposure to emerging countries capped at 30% of its net assets. The subfund's assets mainly consist of large cap equities (more than €10 billion). However, the subfund reserves the right to invest up to 20% of its net assets in small caps (less than €1 billion) and up to 40% of its net assets in mid caps (between €1 billion and €10 billion).

The subfund reserves the right to invest up to 40% in fixed-income products. At the time of acquisition and for monitoring purposes over the life of the securities, credit risk is assessed on the basis of in-house research and analysis by La Financière de l'Echiquier and using the ratings produced by agencies. The eligible securities in question are deemed to be investment grade, i.e., having a minimum Standard & Poor's rating of BBB- or equivalent or considered as such by the management team.

Forward financial instruments, whether traded on regulated markets or over the counter, can be used to:

- Hedge the portfolio against currency risk and, to a lesser extent, against equity risk when the manager foresees a significant decline in the performance of the markets;
- Occasionally expose the portfolio to equity risk during periods of high subscription. The subfund shall in no event implement a strategy of over-exposing the portfolio to equity risk.

Furthermore, the portfolio management team systematically includes an extra-financial approach in building the portfolio, although extra-financial criteria are not a determining factor in investment decisions.

Cut-off time for centralising subscription/redemption orders | The investor may obtain a redemption on request every business day. Redemption requests are centralised each market trading day before 10 p.m. (Paris time) with our centraliser BNP Paribas Securities Services Luxembourg and executed on the net asset value calculated on the closing price on the day they are centralised.

Valuation frequency | The net asset value is calculated daily except on days when the Paris stock exchange is closed and on French public holidays.

What are the risks and what could I get in return?

Risk indicator



The risk indicator is based on the assumption that you hold the shares for 5 years.

 The real risk can be very different if you opt for an exit before this period, and you could get less in return.

The synthetic risk indicator makes it possible to assess the level of risk of this product compared to others. It indicates the likelihood that this product will incur losses in the event of market movements or if we are unable to pay you.

We have classified the product in risk class 4 out of 7, which is a medium risk class. In other words, the potential losses related to the product's future results are at a medium level and, if the situation deteriorates on the financial markets, it is possible that our ability to pay you will be affected.

Performance scenarios I

The stress scenario shows what you could get in extreme market situations.

Unfavourable scenario: this type of scenario occurred for an investment in the product between 30/12/2021 and 30/12/2022 (1-year scenario) and between 30/03/2015 and 30/03/2020 (5-year scenario)

Moderate scenario: this type of scenario occurred for an investment in the product between 30/08/2014 and 30/08/2015 (1-year scenario) and between 30/04/2017 and 30/04/2022 (5-year scenario)

What happens if La Financière de l'Échiquier is unable to pay out?

The product is a co-ownership of financial instruments and deposits separate from the management company. What are the costs?

Costs over time:
